# <u>Second Reading of Ordinance #2019-86 2<sup>nd</sup> Amendment Preservation Ordinance for Harney County</u>

The County Court discussed Ordinance #2019-86 and Commissioner Dorroh read the proposed Ordinance (second reading) in its entirety. Commissioner Owens discussed the purpose of the Ordinance and the desire of the County to adopt something in a timely manner. If, in the future, the County needs to make changes to the Ordinance then they are open to it but would like to have a legal opinion first before making changes to the Ordinance.
