PURPOSE OF POSITION:

Under the auspice of *Harney County Home Health and Hospice*, the Registered Nurse for Home Health is responsible for the direct line management of the patient care processes. The RN assists the Director with supervision/coordination of all aspects of the skilled nursing operations of Home Health Care as assigned by the Director.

The RN:

- Facilitates clinical management of patients receiving care
- Demonstrates the company's culture of compassion, accountability, and results by displaying the highest standards of clinical integrity, superb follow through and consistency, exceptional customer service, and client satisfaction
- Assists with the development, implementation, and evaluation of referral systems and practices

- Participates in development of practice standards; including measurement and trending of patient outcomes related to care
- Maintains services under pertinent federal and state requirements

- Must be familiar with general use of patient care equipment, including but not limited to; sphygmomanometer, oximeter, infusion pump, other
