

In the County Court of the State of Oregon for Harney County Minutes of the County Court Session

February 7, 2018

The Harney County Court convened in County Court Chamber at 9:15 a.m. on Wednesday, February 7, 2018. Members attending were Judge Pete Runnels, Commissioner Patty Dorroh, and Commissioner Mark Owens. Voucher Approval

Minutes

Commissioner Dorroh made a Motion to approve the Minutes from the January 17, 2018, County Court session. Commissioner Owens seconded the Motion, and with no further discussion the Motion carried unanimously.

Opportunity for Public Comment

Rob Frank expressed his strong opposition to Harney County establishing a rural health clinic through the Harney County Health Department. He feels that the government should not be involved in health care at this level, and believes the catalyst for this decision is that the Harney County Health Department loses money for the County. The County Health Department is a public service and is not supposed to be a profitable venture. His concern is also if the rural health clinic does not prove profitable, but is in fact a liability, it will end up costing the taxpayers of Harney County more money. He also discussed what he sees as an influx of people from outside areas coming to Harney County to take advantage of welfare benefits.

10:15-10:45 a.m. USFS-Overview on Timber Sales Project

Travis Swaim, Pete LaDuke, Arnie Cole, Steve Beverlin presented the Court with the 5-year Timber Action Plan FY2018-2022 and the 2018 Tentative Timber Sale Schedule (Grant and Harney Counties) and discussed the various timber sale projects.

10:45 a.m. Shana Withee, OSU Extension Office, Year-End Review

Shana Withee discussed the Harney County 4-H 2016-2017 year. Topics included 4-H participation, teaching/public outreach & engagements, County Leader role, and Oregon 4-H Japanese Exchange program.

Melissa Woodbury, Educational Program Assistant, provided the Court with pictures and discussed the Harney County Ambassadors Program, including activities such as 2017 Rush Night, Fun Fridays program, and the Babysitter Training.

Dustin Johnson, Range and Livestock Extension Agent, discussed his activities which are highly integrated with the community-based conversations including reduction of occurrence and effects of large scale wildfires, water planning efforts, and Sage Grouse conservation and habitat management. He discussed various educational activities and programs including bringing in experts in irrigation technology and crop management, Sage Grouse eco-based approach management framework, High Desert Youth Range Camp, Science and Sagebrush Steppe, and land management planning and GIS geared towards landowners/managers and agencies.

Vanessa Schroeder, OSU Facility Research Assistant (Sage Steppe Habitat Team), discussed topics including rangeland ecology to support different wildlife habitats, activities to provide science when making land management decisions, larger scale grazing study, weed management, and study focused on indirect effects of grazing.

David Bohnert, Director of the Eastern Oregon Ag Research Center, discussed employment opportunities, and upcoming events to include AI (Artificial Insemination) School March 28-30, 2018 at the experiment station; Range Field Day on June 26, 2018, in LaGrande; and Society for Range Management annual business meeting on June 26-28, 2018, and October 22-25, 2018, there will be a beef industry tour.

Willie Riggs, Director of the Klamath Basin Research and Extension Center and the Regional Administrator, discussed funding for faculty and staff, and changes in the administrative model for OSU Extension.

11:30 a.m. Approval of Jail Inventory Search Policy Resolution #2018-02
Sheriff David Ward and Lt. Brian Needham, Harney County Sheriff's Office, discussed the search policy with the Court. Commissioner Owens made a Motion to approve Resolution #2108-02 (CJ2018-25) in the Matter of a Resolution Authorizing an Inventory Search Policy for the Harney County Jail, and seconded by Commissioner Dorroh. With no further discussion, the Motion carried unanimously.

Amending Ordinance #2018-79, County Uniform Fee Schedule

Commissioner Dorroh made a Motion to approve Ordinance #2018-80 (CJ2018-26, 2018-145) in the Matter of Establishing Harney County's Uniform Fee Schedule for Various County Departments Established under Ordinance #2018-79 and Declaring an Emergency, and seconded by Commissioner Owens. With no further discussion, the Motion carried unanimously.
