June 5, 2019

The Harney County Court convened in County Court Chamber at 9:15 a.m. on Wednesday, June 5, 2019. Members attending were Judge Pete Runnels, Commissioner Patty Dorroh, and Commissioner Mark Owens. Voucher Approval

The Court reviewed accounts payables, signed checks, and approved the vouchers by Court signature.

Judge Runnels led all in the Pledge of Allegiance.

Commissioner Dorroh made a Motion to approve the Minutes from the May 22, 2019 County Court session and Commissioner Owens seconded the Motion. With no further discussion, the Motion carried unanimously.

Bobbi Jo Heany, Harney County Treasurer, discussed the County Court Order in the Matter of Distribution of Sale of County Land Fund. Judge Runnels made a Motion to approve the Court Order in the Matter of Distribution of Sale of County Land Funds (CJ2019-76), and seconded by Commissioner Owens.
