

Deviated Fixed Route Service

The Deviated Route System runs on a one hour headway (that is approximately 30 minutes each direction) from 7:00 AM to 3:00PM and 6:00PM to 7:00PM, and a 90 minute headway (approximately 45 minutes in each direction) from 3:00 PM to 6:00 PM Monday-Friday. The service lines begin at the Harney County Senior Center and End at Hines Park. Morning and early afternoon routes serve Burns and Hines. Late afternoon and evening routes incorporate the Burns Paiute Reservation Monday-Friday. Saturday bus service is every hour from 8:00 AM to 5:00PM with one hour out of service from 12:00PM to 1:00 PM. Pattern A(Burns and Hines) runs 10.41 miles, patter B (incorporating the Burns Paiute Reservation) runs 20.78 miles. 698 people and 192 jobs reside within 0.50 miles of the published bus stops. Deviations up to .25 mile off route are available by appointment. Please allow 10 minutes after scheduled stop time as situations arise during route that may cause delays.

Door to Door Transportation Service

Scheduled door to door service allows passengers to schedule rides to their destination. Drivers will stop at the requested location and will help passengers onto the vehicle and off of the vehicle once they arrive at their destination. Should a passenger need a little extra help, our drivers will assist a passenger from their door to the vehicle and assist him/her to board the vehicle. Upon reaching their destination the driver will also assist the passenger off of the vehicle and to the door of his/her destination. Our compassionate drivers go above and beyond, accommodating the needs of those with varying disabilities with emotional comfort and physical support as needed.
